

# 2023-2024 Shaffer Entertainment Richmond Pool Leagues Captain's Agreement

**PLEASE READ THIS DOCUMENT CAREFULLY !!!**

## Captain's Duties

1. The Captain shall be present at all League meetings. Any team not represented at a Captain's meeting will forfeit all voting rights for that meeting.
2. The Captain shall instruct his/her players as to all VNEA and Shaffer Entertainment League rules and requirements.
3. Captains are responsible for the actions of the entire team and it's guests. It is the Captain's responsibility to ensure that the team act in a sportsmanlike manner and abide by the VNEA & Shaffer Entertainment league rules.
4. Captains must be present for the entire match and must verify and sign the score sheet and league envelope. It is the home team Captain's responsibility to verify the envelope contents and to turn the envelope in at the designated location by the designated time. Any shortage of money must be documented on the envelope by the home team. The home team will be charged for any short age NOT documented.

## Fair Play Clause:

Shaffer Entertainment Strives to create a fair and equitable environment for all of our players and teams. We believe that continued growth and sustainability of our programs requires sportsmanship and fair play from everyone who participates in or is involved in our leagues.

Shaffer Entertainment does not condone any actions that create an unfair advantage for a team or player over another. For example, this includes but is not limited to: intentionally losing matches, bribing, gambling, play under other people's names, or any manipulation of your player or team ratings.

Shaffer Entertainment reserves the right to ban any player or team that is in violation of the Fair Play Clause and will result in a forfeiture of any fees or winnings for that league or event. This would also result in forfeiture of future leagues and tournament events.

## Unsportsmanlike Conduct Policy

All players are expected to act like adults during pool league. All personal differences should be left at home. While you are encouraged to support the bars, getting OVER intoxicated is unacceptable during pool league, save it for after the match.

1. Non violent Unsportsmanlike Conduct: First Offense: Warning, Second Offense: ONE YEAR suspension from ALL Shaffer Entertainment leagues. Third Offense: THREE YEAR suspension from ALL leagues. Fourth offense: Lifetime Ban
2. Unsportsmanlike Conduct policy involving violence: Any League player(s) that become involved in a physical altercation, including but not limited to punching, shoving, wrestling or anything else that may be perceived as a fight, will be suspended from ALL Shaffer Entertainment leagues as follows: First Offense: Automatic TWO YEAR suspension. Second Offense: Lifetime Ban.
3. Anyone having been suspended is no longer eligible to be a team captain upon reinstatement.

Match sites - ALL matches are to be played at the scheduled site unless approved in advance by the league coordinator. There are no exceptions! Unapproved moved matches will result in both teams involved receiving zeros.

Sanction Fees & League Fees - The \$20 Sanction fee must be paid the first night a player shoots or the points scored will be forfeited. The FULL weekly fee is due in full for the entire team regardless of how many team members are present to play.

Team Commitment: All teams, once entered into the League schedule, are expected to complete the league season and pay all the league fees. Teams that quit before the completion of the league schedule will result in ALL MEMBERS of the team being suspended from Shaffer Entertainment league for a period of TWO YEARS.

Late Envelopes & Short Envelopes: Envelopes that are late or short of money (even as little as \$1) will result in the following: First & Second offenses: = \$20 Fine. Third offense: will result in a \$20 fine and loss of 5 round points. **Fourth offense:** will result in the team Captain being suspended for the remainder of the Season and loss of Captain eligibility in future seasons.
